1. Purpose of processing, legal basis, the period of storage and types of data collected

2. Recipients of the data

3. Data transfers

Any transfer of data to a country outside the European Economic Area shall be carried out in accordance with the applicable regulations and in such a way as to protect your data appropriately.

6. Your rights / Contact

In accordance with the current regulations, you have the right to access and correct your data. Regarding processing based on the performance of a contract or the implementation of pre-contractual measures, you have also the right to delete your data and to data portability and you can request a restriction of processing.
